Coney Island Yard (Tower B), Essex Street and East New York Yard.

<u>Tower Operators</u> will be governed by the RTO Supervisor In-Charge.

Excursion Train: Supv. In-Charge: IRT Redbirds (Corona Fleet) R-33s and R-36 type equipment

Train Service Supervisor on board the Excursion Train
Routing and routing changes of this Excursion Train will be made at the

discretion of the RTO Supervisor In-Charge.

Route:

1. At 0830 hours the Excursion Train, will leave Coney Island Yard and proceed lite to 59 Street/Columbus Circle (Track A3).

- 2. At 0930 hours, guests will board the Excursion Train at 59 Street/Columbus Circle station, middle platform.
- The Excursion Train will proceed south via the "A" Line to Pitkin Yard, relay and operate to Rockaway Park.
- The Excursion Train will proceed north via the "A" Line to north of Jay Street/Borough Hall, cross to Track B2 and operate to north of West 4 Street and relay on Tracks B4/B3/B1.
- The Excursion Train will proceed south via Track B1 from north of West 4 Street to south of Broadway/Lafayette, cross to Tracks BJ1/J1, and proceed via the "J" & "L" Lines to Rockaway Parkway, where a lunch stop will be made.
- 6. The Excursion Train will proceed north by Tracks P2/Q2 to north of Broadway Junction, relay and operate via Tracks Q1/P1 to north of Atlantic Avenue. Change ends and operate "Against the Normal Direction of Traffic" via Tracks JA1/J1 to Broadway Junction. Then north via the "J" Line to 111 Street and relay.
- 7. The Excursion Train will proceed south via the "J" Line to Track J3/4 at Broadway/Myrtle Avenue, then via the "M" Line to Metropolitan Avenue.

Route Continued:

- 8. The Excursion Train will proceed south via the "J" & "M" Lines, to Chambers Street where guests will detrain.
- 9. The Excursion Train will then return light to Coney Island Yard.

Pertinent notes:

- Personnel responsible for and/or assigned to the operation of a General Order who are uncertain about, or find variations inconsistent with rules, instructions and description of operations, must immediately seek clarification from the appropriate Supervisor/Manager or Desk Superintendent.
- The Train Service Supervisor on board the Excursion Train will be the RTO Supervisor in-charge and will notify the Subdivision "B" Desk Superintendent (718-243-4311) before starting and upon completion of this excursion.
- The Excursion Train will operate between regular train service and under the direction of the Desk Superintendent.
- Yard Dispatcher on duty at Coney Island Yard must ensure that the Excursion Train leaves Coney Island Yard no later than 0830 hours.
- RTO Supervisors will ensure that the Excursion Train is not delayed when transporting guests, and that the excursion train does not delay scheduled intervals.
